RESOLUTION 17-010

A RESOLUTION DECLARING THE OFFICIAL INTENT AND REASONABLE EXPECTATION OF THE BOARD OF SPRINGFIELD TOWNSHIP TRUSTEES ON BEHALF OF THE STATE OF OHIO SPRINGFIELD TOWNSHIP TO REIMBURSE ITS GENERAL FUND FOR THE WOLF CREEK EXECUTIVE PARK AND CENTENNIAL RD. ROAD PROJECTS (OPWC PROJECT NO. CL28U), AND THE GEISER RD., HIDDEN MEADOWS, HIDDEN SPRINGS, AND HILL AVE. ROAD PROJECTS (OPWC PROJECT NO. CL25U) WITH THE PROCEEDS OF TAX EXEMPT DEBT OF THE STATE OF OHIO.

The Board of Trustees of Springfield Township, Lucas County, Ohio, met in regular session on July 17, 2017, at 7617 Angola Road, Holland, Ohio, with the following members present:

Marylin Yoder moved the adoption of the following Resolution:

BE IT RESOLVED by the Board of Springfield Township Trustees on behalf of the State of Ohio that:

- Section 1. The Board of Springfield Township Trustees reasonably expects to receive a reimbursement for the project named Wolf Creek Executive Park and Centennial Rd. Road Project as set forth in Appendix A of the Project Agreement with the proceeds of bonds to be issued by the State of Ohio.
- Section 2. The maximum aggregate principal amount of bonds, other than for costs of issuance, expected to be issued by the State of Ohio for reimbursement to the local subdivision is \$289,340.00.
- Section 3. The Fiscal Officer of the Board of Springfield Township Trustees is hereby directed to file a copy of this Resolution with the Board of Springfield Township Trustees for the inspection and examination of all persons interested therein and to deliver a copy of this Resolution to the Ohio Public Works Commission.
- Section 4. The Board of Springfield Township Trustees finds and determines that all formal actions of this township concerning and relating to the adoption of this Resolution were taken in an open meeting of the Board of Springfield Township Trustees and that all deliberations of this township and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.
- Section 5. This Resolution shall be in full force and effect from and immediately upon its adoption.
