NOTICE OF LIGHTING ASSESSMENT RE-CERTIFICATION

The Board of Trustees of Springfield Township, Lucas County, Ohio, met in regular session on July 2, 2018 at 7617 Angola Road, Holland, Ohio, with the following members present:

Robert Bethel moved the adoption of the following Resolution:

WHEREAS, there are existing street lighting contracts and variable rates with Toledo Edison Company for the following lighting districts:

WHEREAS, this reassessment to the Lucas County Auditor's Office must be submitted periodically based upon renewals, increases in rates, newly completed lighting districts, and splits and combines that have occurred during the year; and

WHEREAS, the cost and expense of lighting these districts shall be assessed against all properties abutting upon the streets and roads in these districts.

THEREFORE, BE IT RESOLVED, by the Springfield Township Board of Trustees, Lucas County, Ohio in accordance with the Ohio Revised Code section 515.02 and 515.11, does hereby reassess the above lighting district costs and expenses as indicated in Exhibit 1 for the current remaining contract years with Toledo Edison.




Tom Anderson Jr. seconded the motion, and the roll being called upon its adoption the vote resulted as follows:
