WHEREAS, Most notable, Chief Helminski through his many positions and responsibilities has been instrumental in the protection of our community and personally responsible for saving countless lives over his thirty five (35) year career; and

WHEREAS, Assistant Chief Helminski has decided to retire from the Fire Department on July 3, 2020 after thirty five (35) years of dedicated service.



